Eligibility requirements

- Applicant must be a residential members of Kosciusko REMC.

Program parameters

- All rebated equipment must be new. Used or rebuilt equipment is not eligible for an incentive.
- Incentive items must be installed on the Kosciusko REMC account listed on this application.
- Rebated equipment must meet the technical specifications listed in this application form.
- A limit of two rebates will be given to any member.

Application procedures and deadlines

- Applications should be submitted within 60 days after the installation date. An invoice/receipt, AHRI certificate and photos must be included for the application to be considered complete.
- Rebated equipment must be installed and operational on or after January 1, 2018 and on or before December 31, 2018. All applications should be postmarked by January 15, 2019.

Ability to confirm installation (if requested)

- Kosciusko REMC reserves the right to inspect the program participant's equipment to verify that it meets program qualifications
- If any requested inspection finds the program participant or the program participant's contractor did not comply with program rules and standards, any incentive received must be returned within 60 days of notice of such noncompliance.

Payment

- Residential rebates will be issued as bill credits on the account listed on the application.
